After registration, all payments must be executed within the terms herewith irrespective of attendance. Should a portion of the Contract price be subject to state, federal, or local taxation, or VAT if applicable, the Organizer reserves the right to add such charges to the final invoice or recover such sums from the Client at the time when they become due.											
3. Cancellation/Substitution: Substitution is allowed by providing a written notice is given to the Organizer, not later than 2 working days before the event. Otherwise, all registrations carry a 50% cancellation liability of the contract value immediately after an authorized registration form has been received by the Organizer. By signing this registration form, the client agrees that in case of any dispute or cancellation the Organizer will not be able to mitigate its losses for any less than 50% of the total contract value.
